All Terrain Vehicles (ATV's) present a risk of Death or Severe Injury in certain circumstances. While accidents may occur for many reasons, the Consumer Product Safety Commission has concluded that: Many people, especially including children have died in accidents involving ATV's. Many people have become paralyzed or suffered internal injuries as a result of accidents involving ATV's.

Every month, thousands of people are treated in hospital emergency rooms for injuries received while riding an ATV.

You should be aware that an **ATV is not a toy and can be Hazardous to Operate**. An ATV handles differently from other vehicles, including motorcycles and cars. A collision or roll over can happen quickly, even during routine maneuvers such as turning, driving on hills and over obstacles, if you fail to take proper precautions.

A Competent Adult must initial each Paragraph Acknowledging that they have Read and Understand each statement and that Attention to each and every Safety Item is Necessary to Avoid Accidents, Severe Personal Injury or Death.

	Never Operate an ATV without wearing an Approved Motorcycle Type Helmet, Eye Protection, Boots, Gloves, Long Pants, and a Long Sleeved Shirt.
	Never Consume Alcohol or Drugs before or while Operating an ATV
